A Letter From Our Board of Directors

To our donors and corporate supporters, the board of directors for the United Fund of Surry thank you for your unwavering support during what has been truly unprecedented times. This report covers the United Fund of Surry's campaigns for 2019-2020 and 2020-2021, with the first campaign ending as the Covid-19 pandemic began and the later campaign conducted amid the pandemic.

We successfully exceeded our campaign goal in 2019-2020 raising \$461,169, surpassing our goal of \$450,000, thanks to a \$50,000 unsolicited grant received due to the pandemic. In 2020-2021 the goal was reduced, due to anticipated pandemic difficulties, to \$425,000. With the pandemic restrictions and quarantine orders impacting local businesses and all our neighbors in Surry County, our fund-raising efforts were severely limited to phone calls, virtual events, and letter solicitations, and we fell short of our goal, raising \$370,794.

Although our fund-raising was down 19.6%, the social needs within our county have not decreased. It has been inspiring to witness how our partner agencies have dealt with the pandemic adversity and continued to service their missions in innovative ways, while adhering to safety protocols to protect their clients, volunteers, and staff. Many of our partner agencies altered the way their services were delivered utilizing virtual sessions for counselling, providing drive by pick up for meals, clothing, and medications, and many continued to work remotely providing wellness checks on the most vulnerable populations within our county. This innovation came with longer staff hours, less volunteer support and a higher cost of doing business for most of our agencies. It is truly inspiring to see their commitment, passion, and dedication to those they serve.

As we look forward, we are optimistic and hopeful that the worst of the pandemic is behind us. Now we must re-energize our efforts in support of our community, learn from the past hardships, and emerge from the past difficulties with a renewed spirit of optimism, passion, and inspiration for our mission to strengthen and serve our community by helping to meet the needs of our neighbors.



Our Agencies

Crisis

American Red Cross Responds to local disasters, such as residential fires and weather-related issues. Supports our armed forces and conducts blood drives for local needs.

The Salvation Army Gives a helping hand in times of crisis with the assistance of food, lodging, clothing and medicine. When needed, also gives assistance with rent and utility payments.

The Shepherd's House Provides a 24-hour homeless shelter for families and women that need counseling and other services to help them rebuild their lives.

Surry Domestic Violence and Sexual Assault Program Serves victims of domestic violence and sexual assault and their families. Provides a 24-hour crisis line, helps with expenses to escape situations and emergency shelter. Provides preventative education in schools and the community.

Surry Homeless and Affordable Housing Coalition Provides temporary, transitional housing for homeless families and permanent housing for homeless people with disabilities.

Yokefellow Ministry Helps individuals and families with food and utility assistance.

Seniors

Meals on Wheels Serves clients ages 60+ who are physically or mentally unable to obtain food or prepare meals.

RSVP (Retired Seniors Volunteer Program) Offers a full range of volunteer opportunities for seniors with local and national organizations.

Surry Senior Centers: Pilot Mountain and Mount Airy - Organizes activities, services, and programs that enhance the quality of life for seniors.

Webb Southern Carroll Community Center Provides weekly meal, social interaction & entertainment for seniors.

Medical

Surry Medical Ministries Local doctors, dentists and other medical professionals volunteer weekly to provide medical care and prescription drugs to uninsured individuals.

Mountain Valley Hospice & Palliative Care Assists seriously ill patients and their families from seven locations serving North Carolina and Southern Virginia.

5 Volunteer Rescue Squads Responds 24/7 to medical emergencies. Provides equipment and training for volunteer members. (Ararat Rescue Squad, Dobson Rescue Squad, Blue Ridge Rescue Squad, Mount Airy Rescue Squad, and Pilot Mountain Rescue Squad).

Family and Youth

Armfield Civic Center Camp Pilot Mountain Provides before and after school programs. Offers scholarships for summer day camp program for children.

Blue House Teaching Studio Provides art therapy to adults with disabilities.

Boy Scouts of America, Old Hickory Council Instills positive values, builds character, develops leaders, shapes lives of youth through fun and exciting activities, outdoor adventures, community service, hands-on learning and achievement, and the influence of caring adult role models.

Children's Center of Northwest NC Provides support services of strengthen family relationships and prevent child abuse.

Girl Scouts, Carolinas Peaks to Piedmont Council Builds courage, confidence, and character in young girls.

Parenting PATH Works to prevent and treat child abuse through classes, counseling and in-home visits.

Reeves Community Center Foundation Awards scholarships to children and disabled adults for membership and athletic activities.

Surry Arts Council (Special Needs Program) Provides programs in visual and performing arts for our special needs population.

Surry Friends of Youth Provides family and individual counseling, community service and restitution programs. Coordinates Best Friends program ages 6-17.

American Red Cross

Accomplishments/Highlights

105 individual's homes were made safer through installation of free smoke alarms.

In 2019 almost 900 individuals were certified in First Aid, CPR, AED, and other lifesaving training and in 2020 more than 400 individuals were also certified, even with COVID restrictions.

In 2019 & 2020 more than 10,057 blood donations were received that could save or sustain up to 30,171 lives.

Over 30 volunteers served Surry County in 2020, totally over 3,000 volunteer hours and in 2019 over 50 volunteers serviced over 4,700 hours.

Success Stories

2019: A single mother and her young son found themselves homeless with only the clothes on their backs when their home was destroyed by fire. The American Red Cross was there to offer compassion, understanding and immediate emergency assistance with funding for a temporary stay at a hotel, clothing, and food. As the case progressed our partner agencies assisted with additional clothing and food. This client managed to find permanent housing soon and, again, our partners helped with some furniture and household items.

2020: A family of six returned home from shopping to learn they had lost everything in a house fire. One of our responders met with the clients and provided them with immediate emergency funds to stay in a motel, buy a few changes of clothes and meals for a few days while they searched for new housing. Within a few days, several of our partner agencies, Goodwill, Salvation Army, and Foothills Food Pantry also stepped forward to assist this family by providing additional clothing, food, and household items.







The Salvation Army



Accomplishments/Highlights

During Christmas 2019, over 2,300 children were served and 22,560 gifts were distributed Summer 2019 more than 50 children were provided with camp experiences. The Salvation Army of Mount Airy celebrated its 80th anniversary during the summer of 2019 with a Birthday Bash at Veteran's Park and Homecoming Services in the fall. During the pandemic of 2020 The Salvation Army was able to deliver food, clothing, and Christmas gifts to clients who had COVID or were quarantined due to exposure.





Success Stories

2019: The McDaniel family is made up of a grandmother and grandfather caring for 3 grandchildren. They have sought assistance with us on numerous occasions in the past but over the last year, through strengthened connections between The Salvation Army's church and social service office, the family has gained the confidence to reach for self-sufficiency. The church made the connection with this family through vacation bible school in the summer of 2018 and the officers began to mentor the children and identify, along with grandma, some of the underlying causes of their need for regular assistance. Health issues plague this older couple but with the support system they now have through The Salvation Army church their former stressors are not longer insurmountable issues.

The Shepherd's House

Accomplishments/Highlights

2019: Over 23,000 meals served. 350 volunteers provided 3546 hours of service. Outside of their walls, they assisted over 5,000 people that were experiencing food insecurities. A primary focus in 2019 was community and partnerships. The Shepherd's House established 14 new partnerships and with those they have helped our community become stronger.

2020: The Shepherd's House took a leap of faith and started a new facility in the middle of the Global Pandemic, but still graduated 89% of their clients to affordable housing and stable income.



Success Story - Abel's Journey

We should all ask ourselves each day, am I progressing? Have I improved myself in some way? Have I moved forward or stayed in place? This is something we encourage our clients to do, and something we do with them on a weekly basis. Self-reflection can be a difficult task, but it is essential to the progression of one's self. Tonight, one of our clients will be able to sit in her OWN home to reflect on the hardships she has conquered. Ones she has faced and battled for her son and herself. When Destiny first came to our house of hope she had nothing. She had no job, no car, no support, and had lost custody of her newborn son. Destiny was in a place where other people might have given up. She took the difficult path of bettering herself and getting her child back. Destiny has gained and maintained employment. She now has her own vehicle. She attended her parenting classes. She asked questions, engaged herself in the class, and learned from it. She worked her plan with DSS and showed progression the entire time she stayed with us. Destiny has fought to give her child the mother he deserves. It could have been too easy for her to say "he will be better off in foster care" or "someone else will have the means to support him". NO, she said, this is my child, and I am his mother. She now has the means to support him and has full custody of sweet Abel. Destiny may never tell Abel of the struggles she faced to raise him, as many mothers don't. She will however, never forget them herself. Abel will not have a mother that might think this would be easier alone. She knows the pain she felt alone, and the pain she felt as she fought for Abel. Seeing this woman fight for her family makes every staff member feel they are making a difference. It motivates the entire house from staff to clients. When someone might ask why we put all this time and effort into people, we can smile. We can smile and tell them Destiny's story. We can smile with tears in our eyes as we tell them how Abel touched our hearts. We can say look; they now have a chance at a happy life together. This is why we should always be willing to help one another. Thank you for your hard work Destiny. We wish the best for you and baby Abel!!



Surry Domestic Violence & Sexual Assault Program





Success Story - 2019

A young lady came into our office with a DSS caseworker requesting help with a Domestic Violence Protection Order. Her 7 year old son had reported abuse to his school counselor, who contacted DSS. The mother had previously been to our office several times to discuss her home life and she had been making preparations to leave her children's father, but she was too scared. She told us that the counselor calling DSS was the best way for it to be reported. Over the course of 7 years, she had been through severe physical, emotional, verbal, and financial abuse. Our staff noticed side effects of high levels of stress, hives on her arms, stuttering, inability to focus, and severe anxiety. Her abuser made her believe that if she left, she would have a mental breakdown. She told us that he got her addicted to prescription medication and she had started abusing it due to the abuse. We found her a shelter as close by as possible and helped her go before the Magistrate who granted her protection for the weekend. The DSS caseworker and law enforcement went with her to retrieve a few belongings. Throughout her case we have gone with her to court, given her food and gas cards to help her and her children and made referrals to seek additional assistance. Since living in the shelter, she has enrolled her two small children in elementary and pre-school. She has gotten a full time and part time job and is in the process of finding a home she can afford and a reliable vehicle. We have seen the biggest difference in this young lady since leaving her abuser. She always has a smile on her face, something positive to say and she praises our office staff every time she sees us.

2019 - 953 served, Over 460 volunteer hours served. 2020 - 5400 Crisis/Hotline Support Calls, Over 9700 volunteer hours served.

2020 Accomplishment

An accomplishment for 2020 is our new partnership with other agencies. One relationship we are incredibly proud of is with our new Support Group host, Lena Shook, at Boundless Potential. Lena is an experienced Domestic Violence Counselor and provides services in surrounding counties. She will speak on topics such as recognizing a potential abuser (Red Flags), recovering your self-esteem, signs of different forms of abuse: physical, verbal, emotional/mental, sexual, and financial.

Yokefellow Ministry





Success Story

2019

An elderly couple came to Yokefellow apologizing about having to ask for food, the man had recently become disabled and was unable to work. He had sold his truck and work tools trying to make ends meet. They were concerned about taking from those who might need it more than them. We assured them that they would not be taking from anyone. They left thanking all the volunteers for all they did. They returned a few months later not for food but to give back by bringing a donation. They had gotten back on their feet and were so grateful for our help.

2020

A gentleman told us about his wife who is bed bound with multiple health issues. He leaves work everyday to go home and feed her lunch. He told us what a difference we made in his ability to have food to feed her. Our success stories come from seeing faces of clients turn into smiles as they push to their cars the buggies of needed food.

2019 - 505,175 pounds of food distributed, 50 volunteers providing 8,000 hours of service.

2020 - 9,069 people with food, 36 people with prescriptions, 149 families with utility payments. 484,493 pounds of food distributed.

Accomplishments/Highlights

2019 - 2523 individuals served: 124 Home-bound, 54 Legal Services, 38 General Transportation, 5 Medical Transportation, 1585 served at Surry County Senior Center and 502 served at Pilot Mountain Senior Center. 102 served at RSVP - 44,549 meals served. 102 volunteers provided 10,584 hours of service. More than 500 seniors were served in partnership with HomeInstead Senior Care of Mt. Airy through the Be A Santa Program. This allows homebound seniors to receive a Christmas gift.

2020 - 1213 individuals served: 137 Home-bound, 35 Legal Services, 23 General Transportation, 4 Medical Transportation, 626 served at Surry County Senior Center, and 172 served at Pilot Mountain Senior Center. 85 served at RSVP - 47,272 meals served. 85 volunteers provided 7,215 hours of service.

Success Story

2019

From the adult grandchild of a home-bound client: "You guys made my grandfather's days a lot brighter. He was blind, but every day he would go to the kitchen table and be sitting there waiting. He was never disappointed and he looked forward to that short little visit every day. He would always share with us who brought his meal and what all they had to say. Thank you all for that and all that you do!"



Success Story

2020

Our facilities were closed on March 17, 2020 due to the pandemic. We immediately began offering services in a safer way. The Senior Centers began offering virtual and online programming. Home-delivered meals changed from daily to a weekly delivery of five frozen meals. Staff called all senior participants multiple times each week to check on them and offer connections to any resources they might need. Homebound and senior center participants were sent packets of take-home activities, such as puzzles, links to online activities, adult coloring sheets, and information regarding COVID. We have conducted many drive-thru events including volunteer recognition, special event parties, and a drug-take back day in partnership with Mt. Airy Police Department.

Webb Southern Carroll Community Center





A line dance group of senior citizens from Surry County provide entertainment once a month at the

Webb Center. This encourages the senior citizens to have fun and exercise.
The senior citizens attending the Webb Center for lunch are also encouraged to join in and attend the free line dance classes in Surry County.

Food was delivered to homebound individuals and any leftover food was delivered to those in need.

Accomplishments/Highlights

2019 - Provided a hot meal to 70 to 85 senior citizens from Carroll County, Surry County and surrounding areas, along with entertainment and free transportation (if needed) each Wednesday. 10 volunteers provided 1600 hours of service.

2020 - 70-80 seniors served from Carroll County and Surry County.





Surry Medical Ministries

Accomplishments/Highlights

2019 - 8886 prescriptions filled, 77 volunteers provided 1386 hours of service, 2019 Diabetes Self Management Participants 20 Sessions offered 82% of patients attended more than 60% of classes These patients reduced their A1C by an average of 2.75 points (ranging from .7 to 4.2 reduction)

With new Dental provider partnerships by mid-2019, patients receiving dental care in 2019 increased 8x over 2018

2020 - 9481 prescriptions filled. 55 volunteers provided 5055 hours of service.



Success Story

2019

A long-term SMM patient, "Jan M." often works 2 part-time jobs to support her family as she also cares for her disabled husband. She is dedicated to her health. So, when she came in complaining of shoulder pain and asking for physical therapy or help with her "rotator cuff", our primary care physician listened. He suspected something else. Thanks to our partnerships, "Jan" was sent for diagnostic imaging quickly. Results came back. No referral for physical therapy. No referral to orthopedics for rotator cuff injury. Our physician and nurses sat her down to share.... It's a breast mass. The referral would be for surgery and to oncology. While you and I who have insurance and/or the means to pay, we have the referral made and just make an appointment. Not for folks at this end of the financial spectrum. It's a drawn-out, frustrating, and almost dehumanizing process. Fear. Worry over the unknown, will I even be allowed to get treatment? Who will take care of my family? How will I manage being out of work? Will I die? Our job was to give her hope. Even with our "inside help" she had to wait 4 weeks to be even given notice of an appointment for surgery consultation. With the news of the pending appointment, "Jan" shed tears of relief. She continues with her treatments. Finding the mass now and receiving care quickly was a vital factor with her type of cancer. She has a cancer navigator helping her now. She continues to come to SMM to visit, she's still a bit frightened of the future, but she gets and gives hugs and prayers. Being positive is amazing medicine, hope, that's the difference. SMM continues to help this patient find hope. And she is one of many...

Struggles and Triumphs of 2020

We experienced a 6-week mandatory State shutdown in early 2020, but after reopening, 72% more uninsured patients utilized our services compared to the same time period in 2019. With a donation of 100 masks by a local middle school student using his own money, we kept pharmacy services open with the same 9 volunteers throughout the State shutdown, altering services to curbside. We partnered with the City of Mount Airy and local food banks to distribute masks, food, and medicine in one place, our facility. COVID screenings and registration of our patients were done in the patient's vehicle or at an outdoor tent, if the patient did not have a vehicle. Close to 50% of our patients do not have a consistent phone number, but we reached out to all patients with working phone numbers for welfare calls, arranging appointments if needed and medication deliveries.

Accomplishments/Highlights

2019 - 1911 individuals served. Hospice 1911; Woltz Hospice Home 661; SECU Hospice Care Center 182; Palliative Care 197; Bereavement 45,919 hours, Kids Path 46; Transitions 314, MCCM 32; Pet Peace of Mind 11 families (31 animals) 243 volunteers provided 11,621 hours of service

2020 - 787 individuals served. Hospice 658; Palliative Care 63; Transitions 67; 96 volunteers provided 974 hours of service Volunteers provided 2032 visits to patients and patients families. Our ReSale Shop provided clothing and household needs to partner agency clients when needed.

Success Story

2019

"For two years before my dear wife, Ramona Schaufenbuel, passed away October 14, 2019, I cared for her day and night. Although I had help from Yadkin Valley Home Health and then from Home Instead in Mount Airy, she needed constant attention day and night because of the debilitating disease of Parkinson. Two weeks before Ramona died I contacted you, knowing she was near the end of her life. Ramona Pardue from your office was assigned to her. She was the perfect person to care for her. I had known her from earlier when she worked for Yadkin Valley Home Health. She gave Ramona the attention needed at this stage of her life and also helped me cope with it. After the first day with Hospice I asked for a

Hospital Bed to allow us more access to her from both sides. The very next morning you delivered and set up the bed. For this quick and efficient response I will always be grateful. On the morning of August 14th I called Ramona Pardue, asking her to come over as I thought my wife was near death. Ramona spent 4 hours with me, one on either side of the bed, and walked me thorugh to the final minute. She kept up with her heart while I watched her. In the last minute Ramona said the time was very close, which allowed me to grasp my wife's hands with my right hand and place my left arm around her head. Within 10 seconds Ramona signaled my Ramona was gone. My dad always told us to pray for a peaceful and happy death - this was accomplished and it will always be cherished.

Overcoming 2020

We completed the year with volunteers assisting for only 2 ½ months of the year. This caused an increase in staff need and costs. We began our Transport program of owning and operating our own ambulance used to transport seriously ill patients to our in-patient facilities. This is a cost savings of over \$200,000 per year. We previously paid Surry County and other private transport services for this service. Not only are we saving money, but this also allows quicker access to care and doesn't overburden the 911/EMS system.





Ararat Volunteer Rescue Squad

Accomplishments/Highlights

2019 - We have 31 volunteers and we provided 1755 hours.

We have three members who are or have been involved in various phases of training: a paramedic, who graduated in May of 2019, and two others in paramedic training who will graduate in 2020. Our Captain, Mike Fulk, has been assisting in teaching the NREMT class held in Stuart, VA and one in Martinsville, VA. His knowledge and time has been appreciated greatly. Mike also assists in teaching the Emergency Vehicle Operator Certification Course.

Due to more qualified personnel, our agency has become more efficient in aiding the people in our neighboring communities. Our agency always participates in any special training that assists in meeting the needs of our citizens. We work together with our neighboring agency, Blue Ridge Volunteer. Rescue Squad to ensure that calls in our area are covered 100%.

Success Story

2019

Our agency was called to a patient who had been down for 30 minutes. This was a possible stroke. When our response team arrived on scene, and after following protocol, they concluded that this was in fact a stroke patient. The patient was vomiting and having seizures. The patient had to be assisted with breathing. Our volunteers immediately called for helicopter transport and carried the patient to the landing zone. This patient survived due to the prompt and knowledgeable actions of the Ararat Volunteer Rescue Squad.

Success Story

2020

We were able to purchase 1 acre of land adjoining our property for future development. We continue to work with Blue Ridge Volunteer Rescue to ensure that all calls received within our 2 areas are covered by one of our agencies.

2019

We were awarded 13 rescue saves from the Surry Association of Rescue Squads for last year. At years end we have completed several live saves and are awaiting awards from the county. We also completed our Third annual Christmas fund that assisted a family in need during a very hard time. With this we were able to provide clothing and food to a family of four for Christmas and beyond!

Dobson Rescue Squad

Accomplishment/Highlights

2019 - 500 individuals served. Responded to 798 crises. 30 volunteers, 1798 hours served.

2020 - 669 individuals served. Responded to 669 crises. 32 volunteers, 200 hours served.





Success Story

2020

We have been involved in people's worst times. We ran a call where a patient was involved in a major car wreck and we used the jaws of life to cut this persons car to gain access to the patient. Once the patient was freed from the vehicle, and transported to the ER, after a few surgeries, the patient survived and came by our department to personally thank our squad for the life saving aid we delivered to him.

Success Story

2019

Our rescue squad has become surface water rescue credentialed. Meaning, we have 8 members who have taken and passed water rescue. We are better equipped in helping the community who are in need of this type of rescue. Our department has been training with other departments such as other rescue squads and other agencies to work together as one and become aware of each individual members strengths and weaknesses. On a call where time is critical, it has increased the patients chance of survival especially in situations such as motor vehicle crashes. Our chief has been a member of our department for a few years. He took the position as chief in June 2019. Since he has became chief, our department has become more of a "family" and the morale has boosted tremendously. He has taken the time to talk to each member and become more involved in the department that some chiefs have done in the past. We received a letter in the mail from a family member thanking our department for our prompt response to the 9-1-1 call that was placed and more specifically, our chief, who took the time to make sure each family member on scene were well aware of the patients condition and they just wanted to say thank you for the support he gave them during a "tough call."

2019 - 30 volunteers, 6370 hours served. Awarded 20 Rescue Life Saves. Collectively our members completed 3146 hours of rescue training.

2020 - Responded to 988 crises. 30 volunteers, 6370 hours served.






Success Story

2020

We had the most rescue saves in our departments history with 27 confirmed rescue saves. We had around 11 Medical Saves as well. We had 2 volunteers complete their EMT Certification and 3 complete their Technical Rescuer certification. We responded to a traffic accident on I-74 where we had 3 people trapped inside a car. It was late at night and in a horrendous storm. We were able to safely extricate all 3 patients within 15 minutes of our heavy rescue truck arriving on scene. All patients had significant injuries and were transported by Surry EMS for treatment. This specific call created a challenge for us rescuers because we had low light conditions, heavy rain, thick mud and working on the side of the road, on a steep embankment. We utilitzed ResQJacks, ropes and the jaws of life amongst other tools to safely extricate the patients.

From there they could visit the library and walk to downtown Pilot Mountain. This weekly event was a definite highlight. We were closed for 6 months. All programs were cancelled. We are still struggling to bring back all of our programs. Our membership is recovering slowly. Staffing hours have been cut in several departments.

Success Story

2019

We have incorporated cooking and science lessons into the art work, along with writing and learning about art and artists. We are grateful for our partnership with Lowe's Foods who provides us with snacks. Since there is always more than we need, we then partner with Shepherd's House and deliver all the extra breads, etc. to them. Our students look forward to coming to classes. They come to class ready to share their lives with each other. Stormy wore her "Prom Queen" sash and her wrist corsage to class to show everyone after the prom. Tabitha and Kyle told us about swimming in the special olympics. They brought articles from the newspaper



about their swimming, and bowling teams. Tabitha mentions her November birthday all year long; and when the birthdays come we put candles in the snack and everyone sings. When their family members face illness or death, the students ask for prayers.





Success Story

2020

We were closed from March 15 until mid-July due to quarantines. Once we returned to classes we had fewer students because so many of our population have additional health issues which make them more fragile and vulnerable to any disease. We bought and provided individual student supply boxes so that they could participate safely. Because we were unable to have our normal class schedule due to COVID restrictions, we sent goodie bags/care packages with activities, letters and presents to all our students. Music classes were cancelled since the program which brought many of the students was not allowed to transport them together in their vans, and we did not have a big enough room to space students far enough apart.

Children's Center of Northwest NC



Accomplishments/Highlights

2019 - 437 individuals served. 1212 meals served. 50 volunteers provided 2040 hours of service.

We announced that our organization adopted a new name—the Children's Center of Northwest North Carolina along with a new logo. We updated our name to better reflect the geographic scope of our service area. We began offering a new program; New Beginnings that is available for victims of abuse and crime/violence ages 7-17 in Surry/Yadkin Counties and their caregivers. Services are provided by licensed therapist and include the evidence-based techniques and modalities of Trauma Focused Cognitive Behavioral Therapy and Person Centered Therapy.

2020 - 998 individuals served. 11,635 meals served. 65 volunteers provided 2,960 volunteer hours served.

We had a 261% increase in the total number served by our agency.





Success Story

2019 (letter from previous client)

"I hope this letter finds you in high spirits. Well, I would like to bring you up to date with what's going on in my world. Well shortly after leaving CCOS I found myself homeless, running with wrong people, and doing a variety of drugs. I eventually ended up in prison and dug myself deeper into a hopeless position. I believed I would always live that lifestyle so I proved myself right. I joined a gang, got into more trouble in prison, and got angrier the deeper I got. I would get out only to go back to the same people, places, and doing the same things. I was in a vicious cycle, get high, chase women, get locked up and repeat. I finally just hit bottom and realized I couldn't continue the way I was living. It was either get help or die. I finally asked for help and not just for money, food, or clothes, but help changing who I was. I hated myself and I knew I couldn't be happy if I hated myself. It's funny when you ask for help how things start to happen. Doors that I could have never opened began to open and doors I didn't know needed to be closed began to close. I found a 12 step program and got a sponsor who helped me form a relationship with God, correct some of my defects and taught me how to help others. Before you know it I changed, I am no longer filled with hate, shame, fear and guilt. I am actually quite loving, compassionate, and happy. I have been clean and sober for 3 years now. I am engaged to marry a beautiful woman. I find it hilarious because she is a social worker. I am 50 credits into my associate degree and I am working in the construction industry as a plumber, which I am doing an apprenticeship for that. I am living a life I never thought was possible. I always thought I would remain at a low socioeconomical status like I said I believed I was born poor white trash and I was gonna die poor white trash. Today I believe I can do right. I need your help. I have caused harm to CCOS and people associated either directly or indirectly. I would like to make amends. I plan to donate money periodically to give the children opportunity, but I want to communicate to that I am willing to do anything to make things right. I can make a trip to talk to with you and whoever wants to participate and discuss the specifics in person. CCOS saved my life and I would like to express my gratitude."

Successes of 2020

We expanded our mental health services and Teen Court services. We were able to assist a child with placement in the Surry Home and he has received tutoring, life skills, and his parents were served with our parenting program while we provided supervised visitation. The wrap around services allowed this family to be reunited in a safe and healthy environment. We are able to continue to provide support services for this family to help them become successful.

Girl Scouts Carolinas Peaks to Piedmont, INC.





Accomplishments/Highlights

2019 - 174 individuals served. 75 volunteers provided 5000 hours of service. Service Projects this year included: Assistance with blood drives for the Red Cross. Donated items to the Children's Center. Donated food items to Hospice. Made clothing donations to the Salvation Army. Donated items for the Shepherd's House. Upkeep for 6 Blessing Boxes around the county. Collaborated with the Charles H. Stone Library in Pilot Mt. to provide programming for disadvantaged children.

2020 - 174 individuals served. 57 volunteers provided 2964 hours of service. 4 girls earned the Girl Scout Gold Award, the highest award in Girl Scouting. Our Cadette Girl Scouts (grades 6-8) earned the Program Aide patch by providing virtual programs for elementary Girl Scouts in lieu of meeting in person.

2019

An older troop has stayed together, engaged and focused, and is in the pipeline to receive the highest award, Girl Scout Gold Award with the next 1-2 years. There is significant socio-economic diversity

among this troop which makes their stories, their reasons for sticking with it all the more compelling. They have discovered all the ways they are similar and have learned to celebrate their diversity. Troop year-end report tracks progress in "soft skills". These soft skills include: increased confidence in each girl and her abilities; increased comfort and willingness to try new things, make a bold choice and learn from mistakes; increased demonstration of acting ethically, honestly and responsibly; increased ability to identify problems and develop action plans to solve problems, and increased ability to communicate feelings and calmly resolve conflicts. Autumn decided this year that it was her turn to give back. Autumn joined a troop when she was a Daisy. She went through 13 years of Girl Scouting and earned her Bronze and Silver awards. She was a crucial part in planning regional events and earned her Service to Girl Scouting pin every year through her middle and high school years. She was also a Program Aide and a Counselor in Training. After graduation Autumn began attending Surry Community college and missed all of the fun she had in Girl Scouts. After a discussion with her mother Autumn decided it was her turn to make sure that more girls got the opportunities that she had. Autumn and her mother started a new Daisy troop and they can't wait to make sure that the next group of Girl Scouts has the numerous amazing memories that Autumn has. She also joined out service unit team and has already planned 2 county wide events. Her enthusiasm is contagious and I can't wait to see the ongoing positive changes Autumn will give back to her community.

Success Story

2020

Two Cadette Girl Scout troops organized a food donation drive for the multiple blessing boxes that a previous Cadette Girl Scout troop had built for their Girl Scout Silver Award project. The girls gathered food from all 19 troops in Surry County and then delivered to the blessing boxes located in Mt. Airy, Dobson, Pilot Mountain, Westfield, and Elkin. They were able to keep the boxes full all summer long before they went back to school.





The Parenting PATH



Accomplishments/Highlights

2019 - 156 indviduals served. 8 volunteers providing 20 hours of service. We are very excited to have a new partnership with the Children's Center of Northwest North Carolina. This collaborative project serves families utilizing the Nurturing Families program. Families receive weekly home visits for 16-24 weeks. In the home visits, parents learn about nurturing parenting routines, alternatives to hitting, child development, and ways to build self esteem in children.

2020 - 307 individuals served. Intensive Family Preservation Services (60 families, 232 individuals), Parent Teen Solutions (7 families, 27 individuals), Positive Effective Parenting 10-week class/Father's class (4 families, 14 individuals), Parent Support (3 families, 14 individuals), Clinical Services (3 families, 20 individuals).

Success Story

2019

A family was referred by Social Services. The social worker expressed concern that the family did not have stable housing which created an unsafe environment

for the children and substance use and mental health issues that were not addressed. The family consisted of a mother in her late 20's, a father in his early 40's and a toddler. The toddler was in kinship care with a paternal cousin. The mother experienced a relapse early in the intervention process. The Parenting PATH staff member assisted the mother in utilizing mental health services, such as Daymark Recovery and Family Medicine to begin therapy and medication. The social worker implemented random drug screens to monitor the substance use of both parents. In addition to examining child development, parent education included the negative impact of substance use and the risk factors when drugs are used while caring for a child. Handouts were provided and discussed. A safety plan was created with the parents and they were encouraged to never use or provide care to their child under the influence. This plan included identifying a safe and sober adult if a relapse were to occur. The Parenting PATH staff was also able to assist the family in locating a trailer in their preferred community. Funds were used to secure a mattress and household items. At closing the toddler was returned to the home and the case was closed out with DSS.

Success Story

2020

"Dear The Parenting PATH:

My name is (PARENT) and I am the grandmother of six children. My oldest grandchild, (GRANDSON), is 13 years old. He has been staying with me a majority of his life. We were referred to The Parenting PATH through the Department of Juvenile Justice when my grandchild had made a threat at school. The Parent Teen Solutions program through The Parenting PATH helped improve communication between my grandchild and his mother, knowledge of supervision needs, expectation setting, and problem solving skills. I offer special thanks to Parent Support Specialist for her part in handling our referral with care, treating me with dignity, respect, and patience while partnering with my family. I keep The Parenting PATH as a reference in case of future need of services for my family. I've shared that he has not had any anger outbursts and he has continued practicing coping skills. He is over his anxiety and has been attending school regularly without complaint! I will definitely recommend this program to families in need of support. The summer of 2019, we assisted with meal deliveries for approximately 100 children each day and provided recreational opportunities at each of the four Mount Airy Housing Authority Sites. Success Story

2020

The ELISS Grant in partnership with Mount Airy City Schools and the NRPA Youth Mentorship Grant touched the lives of many school age children during a time where schools were not able to offer outside activities due to COVID. We had 20 youth participate in an NRPA Youth Mentorship Program.

Accomplishments/Highlights

2019 - We had 4724 members (including family members), 1008 children participated in youth athletics, 886 children participated in swim lessons, 161 children participated in summer camps, 67 in afterschool care and 886 adults participated in adult athletics. 800 volunteers provided 8,000 hours of service.

2020 - 98 scholarships were awarded to ind, families, the Children's Center and youth mentorship program mentees. We had 1591 members in 2020 (including family members), 1163 participated in youth athletics, 125 children participated in our Learn to Swim program.

We had a significant surge in attendance at the monthly free movies, we continued to maintain a positive and inviting relationship with Lifespan, and we had EC classes from schools attending our programs. We also continued our special friends program which features craft workshops, drama, a recital, dance, free movies, and a variety of other events including theater, concerts, performances, and amphitheatre events that allow participants to attend free of charge.

2020 - 109 individuals served. 40 line dance participants - 27 middle/high school crafts - 30 Movies (January and February only).

To this day, he still has that picture up in his room, and he even brings it in to line dance class, sometimes!"

She repaired the guitar and then let the two individuals play the music and sing while the rest of the participants danced to the live music and vocals.

Success Story

2019

Nick has been part of the Best Friends Program at Surry Friends of Youth since July of 2018. He was referred to the Best Friends Program because of his low self-esteem, lack of friends, lack of social skills and not getting along with his mother and grandparents at home. The goals we (Nick, mother, myself and volunteer) set for Nick to strive for while in the Best Friends Program are as follows: 1) Gain more self-confidence and self-esteem, 2) Improve at home relationships with his mother and grandparents, 3) To open up and talk to someone about problems in his life, 4) Improve grades at school, 5) Develop better social skills and interaction with his peers. The person who is matched with Nick has done a wonderful job with him since they have been matched. She has become a good friend to Nick. She has taken an interest in his likes and hobbies. She leads by example. She talks to Nick frequently and is a great listener when Nick does decide he is ready to talk about his feelings. The volunteer takes Nick out usually once a week on a variety of different activities. These activities are sometimes fun and sometimes educational. They usually make it to the group activities we have at Surry Friends of Youth. The volunteer has been and is willing to help Nick in any way possible. Nick's progress has been slow but steady in all of the goals outlined. He started this program very timid and very shy. It was extremely hard to get Nick to speak to me, his volunteer or anyone else. Even the most basic and simple questions made him nervous. Over the past year and four months Nick has made progress. He now talks more openly to his volunteer about what he is feeling. He is not as shy and timid as he was before. He has shown an increase in self-esteem and self-confidence. Nick has always been a very well mannered young man at our group activities. He has shown signs of wanting to interact more with other kids his age. It is great having Nick in the Best Friends Program.

Success Story

2020

During 2020, SFoY received a referral from Juvenile Justice for a youth charged with violent assaults. When we first met him, he was arrested after a fight in the courthouse elevator, and received additional charges. Due to the screaming of witnesses, the day has stood out in our memory. We wondered how we would reach him, and it did not seem possible. Over the next six months, court was postponed, and he seemed only more difficult to reach. When the youth was sentenced later, we assigned him to work with our newly hired community service supervisor. The youth exhibited amazing hard work and help. He went on to assist in several community projects and assisted us in helping move several homeless families into transitional housing and repairing homes for the disabled. During this time, the supervisor / informal mentor was able to role model and discuss the youth's previous charges. The youth began to communicate openly



about how his previous relationships affected his temperament and need to control his situation. Staff explained our Anger Management curriculum. After a couple months, the youth asked to join the class. He did this by choice, without a court order, in order to improve his own future. This youth has almost completed the course. He now is actively completing high school and works almost full time. He will continue to volunteer for SFoY after completing the course.
